This Privacy Policy provides information about how we process personal information that we may collect from you and may be used or disclosed by us. Anti-SPAM commitment

Sutton Industrial Products, LLC (SIP) does not engage in the practice of SPAM. We will not send unsolicited emails, newsletters, surveys, or other correspondence unless it is related to a business transaction, product inquiry, or some other customer initiated form of contact.

Personal information that we may collect

SIP may collect personal information relating to business such as: business email addresses, phone and fax numbers, shipping and mailing addresses, and names and titles of key personnel through contact with SIP by phone, fax, email, online forms, or in person.

Analytics and cookies

How we may use personal information

We may use the personal information we collect from you for a number of purposes:

Disclosure of personal information we collect
